*Sales Floor Committee – In charge of making sure the gallery is attended with excellent care and representation. Making sure our space is always clean and ready for business. Sales techniques are recommended as sales for all artists and members are the top priority. Shelves and displays are up to date, clean of dust and properly presented. Committee members will also make sure that all tags are present and correlate with the merchandise on display. The committee has the power to reject or remove any items that do not meet *quality/presentation standards, with proper notification to the curator & artists. Artists make 55% of their art sales plus 20% of other artists' artwork sales.

*Maintenance Committee – In charge of the beautification and overall outside appearance of our Gallery, bathroom, lanai & Gazebo. This involves, but is not limited to, gardening, trash, repairs, renovations, murals, etc.

*Publicity committees - In charge of current Website, Social Media, photos, videos, data entry. Upload/post self-produced materials, as well as the creation and updating of artists' bios.

*Website management receives a payable commission of 55% from their art's sales. Plus 20% of other art sales. Work remotely is optional.

Event Management- Event performer, promoter, coordinator. Performs, plans, promotes, and executes events by managing vendor relationships, booking talent, and creating marketing strategies to drive attendance. They coordinate logistics, handle on-site operations, and ensure attendee satisfaction. Key duties include booking the venue, managing budgets, and overseeing staff, talent, and technical requirements. Work remotely is optional.

*Administrative committee - Responsible for handling the accounting of memberships and taking care of the legal, financial and business matters of the gallery is already established. The administrative committee handles all proposed changes that may affect performance, presentation, economics, finances and/or aesthetics of the gallery, including selection or rejection of applicants. Work remotely is optional.
